



Jump Nation Release and Waiver of Liability Form

Disclaimer for those under 18

must be signed by parent or legal guardian or with their authorisation.

I declare that I am the parent or legal guardian of the child(ren) listed hereunder or I am signing with the authority and permission of the parent or legal guardian of the child(ren) to sign this Disclaimer and Injury Waiver Form.

I confirm that the listed child(ren) is/are under 18 years old and I authorise them to participate in activities at Jump Nation, an indoor inflatable arena which includes but is not limited to: free running, sports court, slide, freefall, jelly mountain, wipeout balls, basher forest obstacle course, toddler area, games or any other activities (collectively hereinafter called "the Activity") organised by Jump Nation.

Whilst attending Jump Nation and whilst partaking in the Activity the child(ren) will be under my care and supervision or alternatively I will ensure that the child(ren) will be placed in the care and supervision of a suitable adult with my full permission.

I understand and accept that the Activity can be physical and strenuous and requires a level of fitness and that the child(ren) should not undertake it unless they are physically fit. I confirm that I do not know of any medical condition that the child(ren) suffer from which might put them at risk of becoming involved in an incident which could result in injury to themselves or others.

I accept that the Activity is dangerous and that by taking part in the Activity there is a possibility of risk to the child(ren) of personal injury or death and/or property damage and I accept these risks on behalf of the child(ren) which they may be subject to while taking part in the activity.

In the event of an accident or injury involving the child(ren), I accept that Jump Nation will not be liable for any direct or indirect loss, damage or injury arising from or associated with their participation in the Activity and I hereby waive all and any claims against Jump Nation in this regard in relation to the child(ren).

I hereby release, waive, forever hold harmless, indemnify and keep indemnified Jump Nation from all claims for any injury, loss or damage sustained by the child(ren) arising from or associated with the Activity. I hereby indemnify Jump Nation against all claims made by any other person against Jump Nation in respect of any injury, loss or damage arising out of or in connection with the failure of the child(ren) to follow safety instructions, guidelines and rules of Jump Nation, its management or staff.

I understand that photographs or videos may be taken occasionally which may be used for publicity purposes. Jump Nation is monitored by CCTV for the safety of our customers and staff.

I acknowledge and accept that this Form may be pleaded as a bar to any action or proceedings taken by me and/or the child(ren) at any time against Jump Nation arising out of or as a consequence of their participation in the Activity.
